The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

The number of sections and students shall be restricted as per the actual facilities in the school.

For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet

Important Notes: 1. The total number of sections of the school shall be restricted to 19 (as per prescribed dimensions) as per the number of class rooms reported during inspection and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by laws

- 2. As per the videography link https://www.youtube.com/watch?v=51qTXlqgKGs , Height of the concrete boundary wall is less than 6ft, as upper half of the boundary wall is covered iron grill (Ref time 4:11). Thus, the school is directed to construct the same as per Board's norms and submit the videography evidence of the boundary wall from all sides in continuity along with aerial view in the compliance within 03 months.
- 3. The school is directed to construct ramp at the entrance/ground level, ramp / lift to access upper floor and separated toilets for CWSN girls and boys on every floor with proper possible infrastructural facilities in accordance with the provisions laid down in RPWD Act within 03 months and submit the compliance.
- 4. The school shall conduct training of its teachers with respective CoE within 3 months and submit the compliance.
- 5. The school is advised to follow the SoPs issued by the Board in respect of labs, library and sports facilities.
- 6. The school shall get all the mandatory certificates renewed periodically.
- 7. The school shall not remove the videography links in the mandatory disclosure section of its website
